SECRET BALLOT ELECTION & TOWN MEETING WARRANT Friday, May 2, 2025 And Saturday, May 3, 2025

To: Freeman Ramsdell, a resident of the Town of Hartland, County of Somerset, State of Maine.

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Hartland in said County and State, qualified by law to vote in town affairs, to meet at the *Irving Tanning Community Center*, in said Town on Friday, May 2, 2025 A.D. at ten o'clock in the forenoon, then and there to act on Article 1 and by secret ballot on Article 2 set out below, the polling hours therefore to be from 10:00 AM until 7:00 PM in the evening;

And, to notify and warn said inhabitants to meet at the *Irving Tanning Community Center*, in said Town on Saturday, May 3, 2025 A.D. at nine o'clock in the forenoon, then and there to act on Articles 3 through 27 as set out below, to wit:

- Art. 1: To choose a moderator to preside at said meeting.
- Art. 2: To elect (1) Selectmen/Assessor/Overseer of Poor for a 3-year term; To elect (3) Budget Committee Members for a 3-year term. To elect (1) RSU 19 Director for a 3-year term.
- Art. 3: To see if the town will vote to authorize the Board of Assessors to apply \$200,000 of the undesignated fund balance to reduce the 2025-2026 tax mil rate.
- Art. 4: To see if the Town will vote to authorize the Board of Selectmen to apply \$10,000 of the undesignated fund balance to the Fire Department reserve account.
- **Art. 5:** To see if the town will vote to authorize the Municipal Officers to accept and expend any or all funds or property from federal, state or private funding in the form of grants or donations, public or anonymous that the Municipal Officers deem appropriate and in the best interest of the Town.

- Art. 6: To see if the Town will authorize the Municipal Officers to dispose of tax-acquired property for Real Estate Lien via quitclaim deed by either (A) offering the property to the former owner(s) or if deceased, to his/her/their heirs/devisees/personal representative for a price equal to all outstanding taxes, interest, fees and cost; or (B) using the process required by 36 M.R.S., § 943-C, provided that if the board is unable to list or sell the property as required by § 943-C(3), the board may sell the property through a competitive sealed bid process in which a notice advertising sale of property shall be published at least twice in a newspaper of general circulation in the county for sale other than to the former owner. Excess sale proceeds, as defined in 36 M.R.S. § 943-C shall be returned to the former owner.
- **Art. 7:** To see if the Town will vote to authorize the Municipal Officers, on behalf of the Town to sell and dispose of any Sewer Acquired properties for non-payment of sewer fees liens thereon, on such terms as they deem advisable and to execute a quitclaim deed without covenant for such property or mobile home.
- **Art. 8:** To see if the Town will vote to authorize the Municipal Officers to dispose of equipment, vehicles or furniture no longer necessary to Town operations that the Municipal Officers deem appropriate and in the best interest of the Town.
- **Art. 9:** To see if the Town will vote to establish Sept 15 & Mar 1 due dates on taxes, and set the interest rate at 7% that shall start accruing and being applied the day after these due dates.
- **Art. 10:** To see if the Town will vote to authorize the Tax Collector to accept prepayments of taxes not yet committed, pursuant to 36 M.R.S.A., sec 506.
- **Art. 11:** To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of the ensuing year's taxes, if necessary.
- **Art. 12:** To see if the Town will vote to authorize the Selectmen to serve as Assessors and Overseers of the Poor.

Art. 23: To see if the Town will vote to accept, expend, and carry forward in a separate account a sum that may be received from the State Department of Transportation Local Road Assistance Program estimated at \$20,000. (Selectmen Recommend)

Art. 24: To see if the Town will vote to authorize the Board of Selectmen to transfer an amount not to exceed 5% of the total town budget between budget categories as they deem advisable to meet unanticipated expenses and emergencies that occur during fiscal year 2025/2026. **(Selectmen Recommend)**

Art. 25: Shall the Town adopt a document and identified changes entitled Municipal Code of Ordinances that was created to organize, codify, and improve the Town's many ordinances to create a better reference document.

** A copy of the Municipal Code of Ordinances is available at the Town Office to review and electronic copies maybe requested.

Art. 26: To see if the Town will vote to authorize the Municipal Officers, on behalf of the Town to negotiate with the Hartland Public Library and the Tri Town Food Cupboard on a long-term lease (that is approved by our insurance company) or the sale of the properties to them in the amount of a \$ 1.00.

(Selectmen Recommend)

Art. 27: To see if the Town will vote for the Hartland Volunteer Fire Department to use a piece of land located off the Canaan Rd on the Landfill property to operate a fire training facility. Facility will be a container with approval from DEP (Department of Environmental Protection) and following the NFPA (National Fire Protection Association) rules.

The Registrar will be in session for the purpose of maintaining the list of voters Friday, May 2, 2025 from 10:00 AM to 7:00 PM. at the Election and Saturday, May 3, 2025 from 8:30 AM to 9:00 AM at the Town Meeting.
